

1 [Airport Professional Services Agreement - ThyssenKrupp Elevator Corporation - Escalator  
2 and Electric Walk Maintenance Services - Not to Exceed \$19,500,000]

3 **Resolution approving Modification No. 1 to Professional Services Agreement for**  
4 **Airport Contract No. 9313 – Escalator and Electric Walk Maintenance Service, between**  
5 **ThyssenKrupp Elevator Corporation and the City and County of San Francisco, to**  
6 **increase the contract term by six months from January 1, 2019, through June 30, 2019,**  
7 **and to increase the contract amount by \$2,500,000 for a new total contract amount not**  
8 **to exceed \$19,500,000 pursuant to Charter, Section 9.118(b).**

10 WHEREAS, On October 22, 2013, pursuant to Resolution No. 13-0216, the Airport  
11 Commission awarded the Professional Services Agreement (PSA) for Airport Contract 9313 –  
12 Escalators and Electric Walk Maintenance Service to ThyssenKrupp Elevator Corporation for  
13 a five year term, at a not to exceed amount of \$17,000,000, for maintenance, repair, testing,  
14 and on-call emergency services for approximately 133 escalators and 43 electric walks at the  
15 San Francisco International Airport; and

16 WHEREAS, On December 17, 2013, pursuant to Resolution No. 451-13, the Board of  
17 Supervisors approved the award of the PSA to ThyssenKrupp Elevator Corporation under the  
18 same terms and conditions as stated above, on file with the Clerk of the Board of Supervisors  
19 in File No. 131055, which is hereby declared to be a part of this Resolution as if set forth fully  
20 herein; and

21 WHEREAS, On October 2, 2018, pursuant to Resolution No. 18-0326, the Airport  
22 Commission approved Modification No. 1 to Contract No. 9313 (hereafter, “Modification  
23 No. 1”), to increase the contract term by six months from January 1, 2019, through June 30,  
24 2019, and to increase the contract amount by \$2,500,000 for a new total contract amount not  
25 to exceed \$19,500,000; and

1           WHEREAS, Charter, Section 9.118(b) provides that agreements entered into by a  
2 department, board or commission requiring anticipated expenditures by the City and County  
3 of \$10,000,000, or a modification to such an agreement having an impact of more than  
4 \$500,000, shall be subject to approval by the Board of Supervisors by Resolution; and

5           WHEREAS, Modification No. 1 is on file with the Clerk of the Board of Supervisors in  
6 File No. 180989, which is hereby declared to be a part of this Resolution as if set forth fully  
7 herein; now, therefore, be it

8           RESOLVED, That the Board of Supervisors hereby approves Modification No. 1 to  
9 Airport Contract No. 9313, Escalators and Electric Walk Maintenance with ThyssenKrupp  
10 Elevator Corporation, to increase the contract term by six months from January 1, 2019,  
11 through June 30, 2019, and to increase the contract amount by \$2,500,000 for a new total  
12 contract amount not to exceed \$19,500,000; and, be it

13           FURTHER RESOLVED, That within thirty (30) days of Modification No. 1 being fully  
14 executed by all parties, the Airport Commission shall provide it to the Clerk of the Board for  
15 inclusion into the official file.
