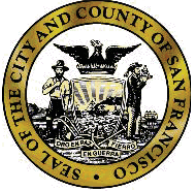

10 WHEREAS, Upon completion of a competitive selection process, on March 17, 2020,  
11 by Resolution No. 20-0046, the Airport Commission awarded the Airport Harvey Milk  
12 Terminal 1 Retail Concession Lease 11 - Lease No. 20-0046 (Lease) to Genesco Partners  
13 Joint Venture #11, a joint venture of Genesco, Inc. and Corliss Stone Littles, LLC, as joint  
14 tenants, dba Johnston & Murphy; and

15 WHEREAS, The Lease has a term of twelve years and an initial minimum annual  
16 guarantee of \$365,000.00; now, therefore, be it

17 RESOLVED, That this Board of Supervisors hereby approves the Harvey Milk  
18 Terminal 1 Retail Concession Lease 11, a copy of which is on file with the Clerk of the Board  
19 of Supervisors in File No. 210675; and, be it

20 FURTHER RESOLVED, That within 30 days of the lease being fully-executed by all  
21 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
22 inclusion into the official file.
