9 WHEREAS, Upon completion of a competitive selection process, the Airport
10 Commission adopted Resolution No. 17-0194 on August 15, 2017, awarding the Domestic
11 Terminals Automated Teller Machines Lease A to Wells Fargo Bank, N.A.; and

12 WHEREAS, The Domestic Terminals Automated Teller Machines Lease A has a term
13 of five years with one option to extend the term by two years, and an initial minimum annual
14 guarantee of \$475,000.00; now, therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Domestic Terminals
16 Automated Teller Machines Lease A, a copy of which is on file with the Clerk of the Board of
17 Supervisors in File No. 171079; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
19 all parties, the Airport Commission shall provide the final Lease to the Clerk of the Board for
20 inclusion into the official file.


