8 WHEREAS, During the years preceding the completion of City Hall and the Legislative
9 Chamber, the Board of Supervisors approved numerous expenditures (bonds) from the City
10 Hall Center Improvement Fund Bond; and

11 WHEREAS, The Board of Supervisors was given the authority to oversee the transition
12 from the temporary City Hall at 1231 Market Street (Hotel Whitcomb); and

13 WHEREAS, The 1916 Board of Supervisors were given the authority to approve
14 and extend contracts for vendors to install furniture, drapes, flooring, and structural
15 enhancements (Exhibit A); and

16 WHEREAS, The Board of Supervisors Clerk staff were given the responsibility to
17 investigate and oversee the assignment of offices in the new City Hall; and

18 WHEREAS, Numerous contractors (Exhibit B) were instrumental in the completion of
19 City Hall during the rebuilding period of the Legislative Chamber; and

20 WHEREAS, Contractors took pride in their craftsmanship to ensure their work would be
21 preserved throughout the next 100 years and more; now, therefore, be it

22 RESOLVED, That Board of Supervisors acknowledges the actions taken by past Board
23 of Supervisors for the completion of the Legislative Chamber, and memorializes the
24 contractors and their outstanding craftsmanship in the rebuilding of the Board of Supervisors
25 Legislative Chamber.
