8 WHEREAS, The Board of Supervisors, being deeply expressive of its appreciation to
9 all former and current Members of the Board of Supervisors for their collective service as
10 public officials, does impart this Resolution to the invaluable Members, both posthumous and
11 those alive and present today in the Legislative Chamber; and

12 WHEREAS, From the very first meeting held in the San Francisco Board of
13 Supervisors Legislative Chamber 100 years ago on October 9, 1916, to the present, each
14 Member of the Board of Supervisors has engaged in lively debates utilizing their intellect and
15 opposing views to enhance the quality of the legislative matters brought by Members to this
16 Chamber for the betterment of this historic town in every aspect, and have taken part in the
17 creation of those empowering laws that make up the San Francisco Charter, Municipal Codes,
18 and Administrative Code that our City and County of San Francisco relies upon; and

19 WHEREAS, With every policy adopted, approved or finally passed – a building block
20 was added to the wondrous strides that have been made here in this City; and with every
21 passing year this City advanced – we saw the appreciation through our population increases
22 and by the distinction of the diversity of the people who wanted, and still want to live, in San
23 Francisco; and

24 WHEREAS, Attracted by the same light, every person who has held or holds the public
25 office of Member of the Board of Supervisors share similar characteristics – they work harder

1 and more hours than they would in their own business to represent each community and to
2 relate to their concerns and needs to make San Francisco the great City it has always been;

4 WHEREAS, Many Members of the Board of Supervisors who dedicated their lives to
5 serving the people of San Francisco are deceased, and we are desirous of adding this tribute
6 to those who have left us, and those alive and present today, and we shall not forget their
7 contribution to this great City; now, therefore, be it

8 RESOLVED, That from this day forward, the legacy left in our keeping, and in the
9 keeping of our successors, is to recognize and thank the Members of the Board of
10 Supervisors, both former and present, for their service to San Francisco; and, be It

11 FURTHER RESOLVED, That in the period of the last 100 years recounting the years of
12 service, the former and present Members of the Board of Supervisors deserve tribute, honor,
13 remembrance, and thanks for their sense of commitment to the citizens and in recognition of
14 every official duty discharged in its fullest detail – we honor each Member of the Board of
15 Supervisors past and present for their faithful service to the people of the City and County of
16 San Francisco.
