13 WHEREAS, The Terminal 2 Specialty Retail Lease No. 2 – Lease No.19-0053 has a
14 term of seven years and an initial minimum annual guarantee of \$225,000; now, therefore, be

16 RESOLVED, That this Board of Supervisors hereby approves the Terminal 2 Specialty
17 Retail Lease No. 2 – Lease No.19-0053, a copy of which is on file with the Clerk of the Board
18 of Supervisors in File No. 190881 and, be it

19 FURTHER RESOLVED, That within 30 days of the lease being fully-executed by all
20 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
21 inclusion into the official file.




