

1 [Accept and Expend Three Gifts - Thomas G. Dragges, James Lund and Jon Simmonds -
2 Airport - SFO Museum Collection - Total Gift Value of \$95,103]

3 **Resolution retroactively authorizing the Airport Director or his/her designee, to accept**
4 **three gifts for the SFO Museum collection: 1) 998 airline and airport timetables valued**
5 **at \$47,435 from Thomas G. Dragges, 2) 73 scale model aircraft valued at \$36,500 from**
6 **James Lund, and 3) 163 commercial aviation artifacts valued at \$11,168 from Jon**
7 **Simmonds; for a total gift value of \$95,103.**

9 WHEREAS, The San Francisco Airport Commission created and operates the SFO
10 Museum located in the International Terminal of the San Francisco International Airport; and

11 WHEREAS, SFO Museum manages a permanent collection for use in public programs
12 in the San Francisco Airport Commission Aviation Library and the Louis A. Turpen Aviation
13 Museum and conducts ongoing collection development through acquisitions by purchase and
14 gift of objects appropriate to the collection focus; and

15 WHEREAS, Three distinct donations of aviation historical materials are being offered
16 from private individuals as gifts to the SFO Museum permanent collection; they are:
17 (1) 998 airline and airport timetables valued at \$47,435 from Thomas G. Dragges; (2) 73 scale
18 model aircraft valued at \$36,500 from James Lund; and (3) 163 commercial aviation artifacts
19 valued at \$11,168 from Jon Simmonds; and

20 WHEREAS, Each gift as offered was deemed appropriate and desirable for
21 accessioning to the collection by the SFO Museum Collections Review Committee; and

22 WHEREAS, Each gift individually is valued above \$10,000, thus requiring Board of
23 Supervisors approval of acceptance of each gift; and

24 WHEREAS, The San Francisco Airport Commission adopted Resolution No. 16-0287
25 on November 1, 2016, authorizing the Airport Director to accept these gifts pending

1 authorization from the Board of Supervisors, which Resolution is on file with the Clerk of the
2 Board of Supervisors in File No. 171082; now, therefore, be it

3 RESOLVED, That the Board of Supervisors retroactively approves the gift of, and
4 authorizes the Airport Director or his/her designee to accept, the 998 airline and airport
5 timetables valued at \$47,435 from Thomas G. Dragges for the SFO Museum collection,
6 consistent with Administrative Code, Section 10.100-305 regarding the acceptance of gifts to
7 the City and County of San Francisco; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors approves the gift of, and
9 authorizes the Airport Director or his/her designee to accept, the 73 scale model aircraft
10 valued at \$36,500 from James Lund for the SFO Museum collection, consistent with
11 Administrative Code, Section 10.100-305; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors approves the gift of, and
13 authorizes the Airport Director or his/her designee to accept, the 163 commercial aviation
14 artifacts valued at \$11,168 from Jon Simmonds for the SFO Museum collection, consistent
15 with Administrative Code, Section 10.100-305; and, be it

16 FURTHER RESOLVED, That the prior execution of the related Deeds of Gift by the
17 Director and Chief Curator of the SFO Museum is hereby ratified, confirmed and approved.
