[Mahsa Amini Day - September 16, 2024]

Resolution declaring September 16, 2024, as "Mahsa Amini Day" in the City and County of San Francisco.

WHEREAS, Mahsa Amini, also known as Jina Amini, a 22-year-old Iranian Kurdish woman, was arrested by Iran's morality police, also known as Gasht-e-Ershad, after being accused of improperly wearing her hijab outside of a metro station in Tehran, allegedly violating the strict Islamic dress code for women; and

WHEREAS, On September 16, 2022, Mahsa (Jina) Amini was pronounced dead while in the custody of the Morality Police, who beat and tortured her while inside the police van that took her to a detention center; and

WHEREAS, In response to her death, protesters took to the streets in more than 80
cities, towns, and villages across Iran; all while Iranian women remain at risk of suffering
brutality and death for perceived violations of a strict imposed dress code; and

6 WHEREAS, Reports indicate that Iranian security forces have used lethal force in
7 killing hundreds of protesters, arrested more than 14,000 people, and have imposed the death
8 penalty on detained Iranians; and

WHEREAS, Mahsa (Jina) Amini's brutal treatment and untimely death became a catalyst the "Woman, Life, Freedom" movement, the first-ever female revolution in Iran, now a global movement, which demands the end of compulsory hijab laws and other forms of discrimination and oppression against women in Iran and basic human rights regardless of gender; now, therefore, be it

RESOLVED, That the Board of Supervisors do hereby declare September 16, 2024, as
Mahsa Amini Day in the City and County of San Francisco; and, be it

Supervisors Safaí; Mandelman, Preston BOARD OF SUPERVISORS

FURTHER RESOLVED, that That the Board of Supervisors affirms its support to the "Woman, Life, Freedom" movement and their fight against human rights violations against women and girls.
