WHEREAS, On February 19, 2019, by Resolution No. 19-0026, the Airport Commission awarded the Professional Services Contract No. 50118.02 ("Contract") to Dignity Health dba St. Mary's Medical Center for Management and Operation of the SFO Medical Clinic ("Clinic") in an amount not to exceed \$5,900,000 for a period of three years, ending on June 30, 2022, with one two-year option to extend, exercisable at the sole discretion of the Airport Commission; and

WHEREAS, On May 28, 2020, the Airport Director approved Modification No. 1 to the Contract to amend the Scope of Services to include onsite COVID-19 testing for Airport Commission employees, and for employees of authorized tenants, service providers, licensees and other occupants of the Airport; and

WHEREAS, On May 18, 2021, by Resolution No. 21-0116, the Airport Commission approved Modification No. 2 to the Contract to increase the not to exceed amount to \$9,400,000 and to reduce the management fee by 50% for fiscal years 2020-2021 and 2021-2022; and

WHEREAS, On April 19, 2022, by Resolution No. 22-0062, the Airport Commission approved Modification No. 3 to the Contract to extend the term through June 30, 2024, reduce

the Clinic's operating hours and increase the Contract amount by \$1,600,000 for a new Contract amount not to exceed \$11,000,000 ("Modification No. 3"); and

WHEREAS, On August 15, 2023, by Resolution No. 23-0201, the Airport Commission approved Modification No. 4 to the Contract to increase the Contract amount by \$1,700,000 for a new Contract amount not to exceed \$12,700,000 ("Modification No. 4"); and

WHEREAS, Copies of Modification No. 4 are on file with the Clerk of the Board of Supervisors in File No. 230908; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves Modification No. 4 to Contract No. 50118.02 with Dignity Health dba St. Mary's Medical Center to increase the contract amount by \$1,700,000 for a new contract amount not to exceed \$12,700,000; and, be it
