## RESOLUTION NO. 497-24

[Supporting United States House of Representatives Bill H.R. 9662 (Senator Smith and Representative Ocasio-Cortez) - Homes Act]

Resolution supporting United States House of Representatives Bill H.R. 9662, the Homes Act, introduced by United States Senator Tina Smith and Representative Alexandria Ocasio-Cortez, to address the affordable housing crisis by establishing a national Housing Development Authority to create permanently affordable, climateresilient housing and provide an alternative to market-rate housing.

WHEREAS, On September 19, 2024, Senator Tina Smith (D - MN) and Representative Alexandria Ocasio-Cortez (D - NY) introduced the Homes Act to increase the supply of affordable homes by constructing new social housing units and creating \$1.3 million affordable homeownership opportunities over the next decade; and

WHEREAS, The Homes Act proposes a \$300 billion investment in the next decade to provide housing stability for low-income households, addressing skyrocketing rents, displacement, and homelessness, and will create more than 400,000 jobs a year, including more than 150,000 construction jobs; and

WHEREAS, The Homes Act will provide funding to rehabilitate and address the backlog of necessary improvements for public housing and repeal the Faircloth Amendment to allow new public housing; and

WHEREAS, On April 2, 2024, the Board of Supervisors unanimously passed Supervisor Dean Preston's resolution (File No.240313) calling on the San Francisco Housing Authority to fully leverage the "Faircloth-to-RAD" option provided by the U.S. Department of Housing and Urban Development (HUD) to create up to 3,668 new deeply affordable rental units in San Francisco with permanent federal subsidies, and passage of the Homes Act could greatly expand this opportunity by lifting the Faircloth cap; and WHEREAS, The Homes Act seeks to expand homeownership opportunities for marginalized communities, including Black, Latinx, and Indigenous households and will provide tenants with opportunities to come together to purchase their buildings prior to large, for-profit developers buying them; and

WHEREAS, San Francisco's Community Opportunity to Purchase Act (File No. 200948), empowers mission-driven nonprofits and public entities to acquire multi-family properties and preserve affordable housing, work that could be expanded with passage of the Homes Act; and

WHEREAS, The Homes Act aligns with the San Francisco Foreclosure Prevention and Acquisition Program, which assists homeowners at risk of foreclosure, by providing relief to mortgage borrowers and supporting shared equity homeownership models; and

WHEREAS, The Homes Act aligns with Resolution (File No.200708) unanimously passed by the San Francisco Board of Supervisors to direct the funds raised by Proposition I in November 2020 to Covid rent relief and social housing; and

WHEREAS, The Homes Act aligns with and would help fund the full implementation of Proposition K (2020) written by Supervisor Preston, placed on the ballot by a unanimous Board of Supervisors, and passed by 73.5% of voters to authorize the development of 10,000 units of social housing; and

WHEREAS, The Homes Act will establish a National Housing Development Authority to acquire and develop real estate to create and maintain a stock of permanent, sustainable, affordable housing, including single- and multi-family housing, with robust tenant protections; and

WHEREAS, The Homes Act will require a cap on rents at 25% of a household's income to ensure housing affordability for low- and moderate-income households; and

WHEREAS, San Francisco's 2022 Housing Element calls for the construction of 46,500 new affordable housing units by 2031, a goal that the Homes Act would help achieve by providing the necessary federal investment to develop social housing and expand affordable homeownership; and

WHEREAS, San Francisco has fallen short of its affordable housing production goal by 9,000 units in the last Regional Housing Needs Allocation (RHNA) cycle, highlighting the urgent need for federal investment to increase the supply of affordable housing; and

WHEREAS, The Homes Act supports climate-resilient and zero-emission housing, aligning with San Francisco's commitment to sustainability as outlined through the Board's ordinance to Mandate New Construction Be All-Electric (File No. 200701), which requires all new residential construction in the city to be fully electric; and

WHEREAS, The Homes Act authorizes \$30 billion in annual appropriations for affordable housing development, including a 5% set-aside for Tribal communities and a 10% set-aside for rural communities, reinforcing San Francisco's calls for increased federal support for housing; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors supports the Homes Act and urges the United States Congress to swiftly pass and implement the Act to increase the supply of permanently affordable, climate-resilient housing and expand opportunities for homeownership; and, be it

FURTHER RESOLVED, That the Clerk of the Board shall transmit copies of this resolution to Senators Alex Padilla, Laphonza Butler, Tina Smith, Speaker Emerita Nancy Pelosi, and Representative Alexandria Ocasio-Cortez.
