4 **Resolution retroactively authorizing the Department of Public Health to accept and**
5 **expend a grant increase in the amount of \$138,434 for a total amount of \$173,063 from**
6 **the National Institutes of Health through Florida State University for participation in a**
7 **program, entitled “Adolescent Medicine Trials Network for HIV/AIDS Interventions**
8 **(ATN) Scientific Leadership Center,” for the period of December 1, 2023, through**
9 **November 30, 2024.**

11 WHEREAS, The National Institutes of Health (NIH), through Florida State University
12 (FSU) as a pass-through entity, has agreed to fund the Department of Public Health (DPH) in
13 the amount of \$173,063 for participation in a program, entitled “Adolescent Medicine Trials
14 Network for HIV/AIDS Interventions (ATN) Scientific Leadership Center,” for the period of
15 January 25, 2023, to November 30, 2024; and

16 WHEREAS, The Adolescent Medicine Trials Network for human immunodeficiency
17 virus (HIV)/ acquired immunodeficiency syndrome (AIDS) Interventions (ATN) Scientific
18 Leadership Group (SLG) will provide the necessary multidisciplinary expertise to set, prioritize
19 and manage the ATN scientific agenda; and

20 WHEREAS, The ATN SLG will develop and refine the research agenda of the ATN,
21 convene working groups as needed, prioritize emerging research projects, efficiently manage
22 the development of clinical protocols, implement and complete clinical trials and ensure timely
23 publication and communication of results; and

1 WHEREAS, DPH will lead the site consortium, support site infrastructure, and
2 contribute to development and implementation of innovative recruitment and retention
3 strategies and maintain internal metrics; and

4 WHEREAS, DPH will lead and contribute to drafting protocol-specific budgets, initiate
5 and maintain community partnerships, and participate in the development of trials; and

6 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

7 WHEREAS, A grant increase of \$138,434 was approved for the period of December 1,
8 2023, through November 30, 2024; and

9 WHEREAS, A request for retroactive approval is being sought because DPH received
10 an increase in grant funds on June 6, 2024, for a project start date of December 1, 2023; and

11 WHEREAS, The grant budget includes a provision for indirect costs in the amount of
12 \$34,613; now, therefore, be it

13 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
14 in the amount of \$173,063 from the NIH through FSU; and, be it

15 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
16 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

17 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
18 Agreement on behalf of the City; and, be it

19 FURTHER RESOLVED, That within thirty (30) days of the Grant Agreement being fully
20 executed by all parties, the Director of Health shall provide a copy to the Clerk of the Board of
21 Supervisors for inclusion in the official file.
