

1 [Accept and Expend Grant - Retroactive - Purchaser Business Group on Health - CalHIVE  
2 Behavioral Health Integration (BHI) Improvement Collaborative - \$100,000]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**  
4 **expend a grant in the amount of \$100,000 from the Purchaser Business Group on**  
5 **Health for participation in a program, entitled “CalHIVE Behavioral Health Integration**  
6 **(BHI) Improvement Collaborative,” for the period of July 1, 2023, through January 31,**  
7 **2027.**

9 WHEREAS, The Purchaser Business Group on Health (PBGH) has agreed to fund the  
10 Department of Public Health (DPH) in the amount of \$100,000 for participation in a program,  
11 entitled “CalHIVE Behavioral Health Integration (BHI) Improvement Collaborative (CalHIVE),”  
12 for the period of July 1, 2023, through January 31, 2027; and

13 WHEREAS, DPH agrees to identify a practice or clinic that will serve as a pilot site for  
14 behavioral health integration; and

15 WHEREAS, DPH will enroll and provide data for all clinicians across their organization  
16 and the identified pilot practice or clinic site through October 31, 2026; and

17 WHEREAS, DPH will be required to complete Phase 1: Preparation/Boot Camp (2023-  
18 2024), and Phase 2: Implementation & Scaling (2024-2026); and

19 WHEREAS, DPH will be responsible for completion of the following program  
20 deliverables for core funding: needs assessment, implementation milestone assessment tool,  
21 behavioral health implementation plan, and sustainability plan; and

22 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

23 WHEREAS, A request for retroactive approval is being sought because DPH received  
24 the agreement on May 17, 2023, for a project start date of July 1, 2023; and

1           WHEREAS, The Department proposes to maximize use of available grant funds on  
2 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

3           RESOLVED, That DPH is hereby retroactively authorized to accept and expend a grant  
4 in the amount of \$100,000 from the PBGH; and, be it

5           FURTHER RESOLVED, That DPH is hereby retroactively authorized to accept and  
6 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

7           FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
8 Agreement on behalf of the City; and, be it

9           FURTHER RESOLVED, That within thirty (30) days of the Grant Agreement being fully  
10 executed by all parties, the Director of Health shall provide a copy to the Clerk of the Board of  
11 Supervisors for inclusion in the official file.
