3 **Resolution determining that the transfer of a Type-20 off-sale beer and wine**
4 **liquor license to Luke's Local, Inc., doing business as Luke's Local, located**
5 **at 2190 Union Street (District 2), will serve the public convenience or necessity of**
6 **the City and County of San Francisco; and requesting that the California**
7 **Department of Alcoholic Beverage Control impose conditions on the issuance of**
8 **the license.**

10 WHEREAS, Luke's Local, Inc., is seeking the transfer of a Type-20 off-sale beer
11 and wine liquor license to do business as Luke's Local, located at 2190 Union Street
12 (District 2); and

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed one protest and zero letters of
16 support with the Department of Alcoholic Beverage Control under California Business
17 and Professions Code, Section 24013, and recommends that the Department of
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the
20 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort
21 to prevent the loitering of persons on any property adjacent to the licensed premises as
22 depicted on the most recently certified ABC-253; and 2) The petitioner(s) shall be
23 responsible for maintaining free of litter the area adjacent to the premises over which
24 they have control, as depicted on the ABC-253; now, therefore, be it

1 RESOLVED, That in accordance with California Business and Professions Code,
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
3 hereby determines that transfer of a Type-20 off-sale beer and wine liquor license to
4 Luke's Local, Inc., doing business as Luke's Local, located at 2190 Union Street, will
5 serve the public convenience or necessity of the City and County of San Francisco; and,
6 be it

7 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
8 San Francisco hereby endorses and adopts the recommendations of the Police
9 Department listed above and recommends that the Department of Alcoholic Beverage
10 Control issue the license with those conditions.
