

1 [Grant Amendment - Japanese Community Youth Council - Opportunities for All Intermediary
2 Program - Not to Exceed \$13,327,411]

3 **Resolution approving a fourth amendment to Contract No. 1000014147 for the**
4 **Japanese Community Youth Council, Opportunities for All Intermediary Program,**
5 **between the Japanese Community Youth Council and the City and County of San**
6 **Francisco, acting by and through its Department of Children, Youth and Their Families,**
7 **to increase the grant amount by \$3,000,953 for a total not to exceed amount of**
8 **\$13,327,411 with Board of Supervisors' approval under Charter, Section 9.118, and with**
9 **no change to the grant term.**

11 WHEREAS, The Japanese Community Youth Council, Opportunities for All
12 Intermediary Program, provides youth with access to work-readiness training, work-based
13 learning, and employment opportunities; and

14 WHEREAS, The Opportunities for All Intermediary Program serves more than 2,018
15 San Francisco youth annually; and

16 WHEREAS, The Opportunities for All Intermediary Program fulfills the Youth Workforce
17 Development Strategy of the Department of Children, Youth and Their Families' Youth
18 Workforce Development Service Area, as described in the department's Request for
19 Proposals issued August 18, 2017; and

20 WHEREAS, The Department of Children, Youth and Their Families entered into a grant
21 agreement with the Japanese Community Youth Council effective July 1, 2019, to June 30,
22 2023, with a not to exceed amount of \$1,958,000; and

23 WHEREAS, The Department of Children, Youth and Their Families amended the
24 original grant agreement on October 8, 2019, to increase the grant amount by \$1,870,000 for
25 a revised not to exceed amount of \$3,828,000; and

1 WHEREAS, The Department of Children, Youth and Their Families entered into a
2 second amendment to the grant agreement with the Japanese Community Youth Council,
3 effective January 9, 2020, to increase the grant amount by \$4,290,000 for a revised not to
4 exceed amount of \$8,118,000; and

5 WHEREAS, The Department of Children, Youth and Their Families entered into a third
6 amendment to the grant agreement with the Japanese Community Youth Council, effective
7 May 23, 2022, to increase the grant amount by \$2,208,458 for a revised not to exceed amount
8 of \$10,326,458 and to extend the grant term to June 30, 2024, as approved by the City's
9 Board of Supervisors by Resolution No. 209-22 (File No. 220061) on May 17, 2022, a copy of
10 which is on file with the Clerk of the Board of Supervisors in File No. 230692; and

11 WHEREAS, The City and County of San Francisco wishes to enter into a fourth
12 amendment to the grant agreement with the Japanese Community Youth Council to increase
13 the grant amount by \$3,000,953 for a revised not to exceed amount of \$13,327,411, with no
14 extension of the grant term; now, therefore, be it

15 RESOLVED, Under San Francisco Charter, Section 9.118, that the Board of
16 Supervisors hereby authorizes the City to enter into the fourth amendment to the grant
17 agreement between the City and County of San Francisco and the Japanese Community
18 Youth Council, increasing the grant amount by \$3,000,953 to \$13,327,411, with no extension
19 of the grant term; and, be it

20 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
21 executed by all parties, the Department of Children, Youth and Their Families shall provide
22 the final grant agreement to the Clerk of the Board for inclusion into the official file.
