

1 [Grant Amendment - Retroactive - YMCA Urban Services - Truancy Assessment and
2 Resource Center (TARC) Program - Not to Exceed \$5,390,219]

3 **Resolution retroactively approving a seventh amendment to Contract No. 1000014469**
4 **for the YMCA Urban Services - Truancy Assessment and Resource Center (TARC)**
5 **Program between the YMCA Urban Services and the City and County of San Francisco,**
6 **acting by and through its Department of Children, Youth and Their Families, to increase**
7 **the grant amount by \$606,040 for a total not to exceed amount of \$5,390,219 and to**
8 **extend the grant term for 1 year from July 1, 2023, for a new term of July 1, 2013,**
9 **through June 30, 2024, with Board of Supervisors' approval under Charter,**
10 **Section 9.118.**

12 WHEREAS, The YMCA Urban Services - Truancy Assessment and Resource Center
13 (TARC) Program is a one-stop resource center for truancy intervention services and supports;
14 and

15 WHEREAS, The Truancy Assessment and Resource Center (TARC) Program serves
16 more than 105 San Francisco youth annually; and

17 WHEREAS, The Truancy Assessment and Resource Center (TARC) Program fulfills
18 the Truancy Reduction Strategy of the Department of Children, Youth and Their Families'
19 Educational Supports Service Area, as described in the department's Request for Proposals
20 issued August 30, 2011; and

21 WHEREAS, The Department of Children, Youth and Their Families entered into a grant
22 agreement with the YMCA Urban Services effective July 1, 2013, to June 30, 2014, with a not
23 to exceed amount of \$446,009; and

24 WHEREAS, The Department of Children, Youth and Their Families amended the
25 original grant agreement on July 1, 2014, to increase the grant amount by \$610,564 for a

1 revised not to exceed amount of \$1,056,573 and to extend the grant term to June 30, 2016;
2 and

3 WHEREAS, The Department of Children, Youth and Their Families entered into a
4 second amendment to the grant agreement with the YMCA Urban Services, effective on and
5 after May 4, 2016, to increase the grant amount by \$676,016 for a revised not to exceed
6 amount of \$1,732,589 and to extend the grant term to June 30, 2018; and

7 WHEREAS, The Department of Children, Youth and Their Families entered into a third
8 amendment to the grant agreement with the YMCA Urban Services, effective on and after
9 May 31, 2018, to increase the grant amount by \$1,096,222 for a revised not to exceed amount
10 of \$2,828,811 and to extend the grant term to June 30, 2019; and

11 WHEREAS, The Department of Children, Youth and Their Families entered into a
12 fourth amendment to the grant agreement with the YMCA Urban Services, effective on and
13 after January 9, 2019, to extend the grant term to December 31, 2019; and

14 WHEREAS, The Department of Children, Youth and Their Families entered into a fifth
15 amendment to the grant agreement with the YMCA Urban Services, effective on and after
16 April 12, 2019, to extend the grant term to June 30, 2020; and

17 WHEREAS, The Department of Children, Youth and Their Families entered into a sixth
18 amendment to the grant agreement with the YMCA Urban Services, effective on and after
19 January 14, 2020, to increase the grant amount by \$1,955,368 for a revised not to exceed
20 amount of \$4,784,179 and to extend the grant term to June 30, 2023; and

21 WHEREAS, The City and County of San Francisco wishes to enter into a seventh
22 amendment to the grant agreement with the YMCA Urban Services to increase the grant
23 amount by \$606,040 for a revised not to exceed amount of \$5,390,219 and to extend the
24 grant term to June 30, 2024; now, therefore, be it

1 RESOLVED, Under San Francisco Charter, Section 9.118, that the Board of
 2 Supervisors hereby retroactively authorizes the City to enter into the seventh amendment to
 3 the grant agreement between the City and County of San Francisco and the YMCA Urban
 4 Services to support the Truancy Assessment and Resource Center (TARC) program,
 5 increasing the grant amount by \$606,040 for a total not to exceed amount of \$5,390,219 and
 6 extending the grant term to June 30, 2024; and, be it

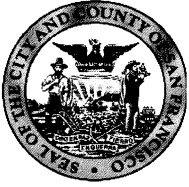
7 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
