3 **Resolution declaring October 8, 2025, as Joseph Leung Day in the City and County of**  
4 **San Francisco.**

6 WHEREAS, Joseph Leung is the current Publisher and Editor-in-Chief of Sing Tao  
7 Daily USA - Western Edition, with more than 36 years of experience in journalism,  
8 broadcasting, and media management, who has become one of the most influential Chinese-  
9 language media figures and a trusted community leader in the Bay Area; and

10 WHEREAS, Mr. Leung graduated from the Chinese University of Hong Kong and  
11 immigrated to the United States (U.S.) and arrived in San Francisco on October 8, 1988 –  
12 exactly 37 years ago; and

13 WHEREAS, Mr. Leung began his broadcasting career in the United States as a humble  
14 news anchor before joining Sing Tao Daily as a reporter and editor; and

15 WHEREAS, In 2002, he was appointed Editor-in-Chief of the Western Edition and was  
16 later promoted to Publisher and Editor-in-Chief, overseeing the newspaper's editorial and  
17 business operations across the Western United States; and

18 WHEREAS, For more than 30 years, Mr. Leung is also a radio and online program  
19 host, whose audiences spread across the United State, Canada, Australia, and Hong Kong;  
20 and

21 WHEREAS, Mr. Leung's YouTube commentary channel has attracted more than  
22 240,000 subscribers, making him one of the first "social media influencers" in the Chinese  
23 diaspora before the word "influencer" was a common cultural concept; and

24 WHEREAS, Mr. Leung has been deeply engaged in community development, public  
25 education, and cultural promotion, having served as the Founding Director and current

1 President of the U.S.- China Culture Experience Consortium, Board Member of the Northern  
2 California Chinese Media Association, and Director of the Sue Hing Benevolent Association,  
3 one of the seven legacy Chinese heritage organizations in the U.S.; and

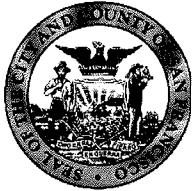
4 WHEREAS, In 2020, during the COVID-19 pandemic, Mr. Leung spearheaded a major  
5 fundraising campaign among overseas Chinese communities and raised nearly \$500,000 for  
6 the Red Cross to support families of frontline medical workers who lost their lives amid the  
7 pandemic; and

8 WHEREAS, Mr. Leung's leadership and achievements have been recognized with  
9 numerous awards, including the Best Broadcast News Commentary Award, Community Hero  
10 Award, Best Feature Report, and Best News Commentary Awards; and

11 WHEREAS, Since 1990, Mr. Leung has called San Francisco home, where he  
12 continues to play a vital role in media leadership, community service, and cultural preservation  
13 within and beyond the Chinese and Chinese American communities; now, therefore, be it

14 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
15 declares that October 8, 2025, shall be recognized as Joseph Leung Day; and, be it

16 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San  
17 Francisco recognizes and celebrates the contributions of Joseph Leung to our City.




