1 [Contract Amendment - Hyde Street Community Services - Behavioral Health Services - Not  
2 to Exceed \$27,030,997]

3 **Resolution approving Amendment No. 1 to the agreement between Hyde Street**  
4 **Community Services and the Department of Public Health for behavioral health**  
5 **services, to increase the agreement amount by \$17,556,558, for an amount not to**  
6 **exceed \$27,030,997; and to extend the term by five and one-half years, from January 1,**  
7 **2021, for a total agreement term of July 1, 2018, through June 30, 2026.**

9 WHEREAS, The Department of Public Health's (DPH's) Behavioral Health Services  
10 (BHS) selected Hyde Street Community Services to provide mental health outpatient and  
11 intensive case management services under two RFPs that DPH conducted in 2017; and

12 WHEREAS, DPH subsequently entered into an agreement with Hyde Street  
13 Community Services to provide these services for two and one half years, July 1, 2018,  
14 through December 31, 2020, for an amount not to exceed \$9,474,439; and

15 WHEREAS, DPH wishes to continue services under that agreement for the full term  
16 stated in the RFPs; now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public  
18 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the  
19 City and County of San Francisco, to execute Amendment No. 1 to the agreement with Hyde  
20 Street Community Services for behavioral health services for an amount not to exceed  
21 \$27,030,997, for the term of July 1, 2018, through June 30, 2026; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of  
23 Public Health to enter into any amendments or modifications to the contract, prior to its final  
24 execution by all parties, that the Department determines, in consultation with the City  
25 Attorney, are in the best interests of the City, do not otherwise materially increase the

1 obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of  
2 the contract, and are in compliance with all applicable laws; and be it

3 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
4 by all parties, the Director of Health and/or the Director of the Office of Contract  
5 Administration/Purchaser shall provide the final contacts to the Clerk of the Board for inclusion  
6 into the official File No. 201244.
