[Contract Amendment - A Better Way - Mental Health Outpatient Treatment Services and Optional Specialized Mental Health Treatment Services - Not to Exceed \$13,579,299]

Resolution approving Amendment No. 2 to the Agreement between A Better Way and the Department of Public Health (DPH), for mental health outpatient treatment services and optional specialized mental health treatment services; to increase the agreement by \$3,799,272 for a total amount not to exceed \$13,579,299; to extend the term by three years and six months from December 31, 2023, for a total agreement term of July 1, 2017, through June 30, 2027; and to authorize DPH to enter into amendments or modifications to the contract prior to its final execution by all parties that do not materially increase the obligations or liabilities to the City and are necessary to effectuate the purposes of the contract or this Resolution.

WHEREAS, The Department of Public Health (DPH), selected A Better Way through a Reguest for Proposals process, RFP 33-2016, issued on November 2, 2016, and RFP 1-2017, issued on March 7, 2017, to provide mental health outpatient treatment services and optional specialized mental health treatment services; and

WHEREAS, DPH entered into an original agreement with A Better Way on July 1, 2017, with the term of July 1, 2017, through December 31, 2021, in an amount not to exceed \$9,327,033; and

WHEREAS, DPH amended the agreement between DPH and A Better Way on January 1, 2022, to extend the term for two years from December 31, 2021, through December 31, 2023, adding \$452,994, for an amount not to exceed \$9,780,027; and

WHEREAS, DPH wishes to amend the agreement to continue providing mental health outpatient treatment services and optional specialized mental health treatment services, by extending the term by three years and six months, from December 31, 2023, through June 30, 2027, increasing the contract by \$3,799,272 for a total contract amount not to exceed \$13,579,299 and for a total agreement term of July 1, 2017, through June 30, 2027; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the City and County of San Francisco, to execute Amendment No. 2 to the agreement with A Better Way to provide mental health outpatient treatment services and optional specialized mental health treatment services, increasing the contract by \$3,799,272, for a total contract amount not to exceed \$13,579,299, and for a total agreement term of July 1, 2017, through June 30, 2027; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of Public Health to enter into any amendments or modifications to the contract, prior to its final execution by all parties, that the Department determines, in consultation with the City Attorney, are in the best interests of the City, do not otherwise materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the contract, and are in compliance with all applicable laws; and, be it

FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed by all parties, the Director of Health and/or the Director of the Office of Contract Administration/Purchaser shall provide the final contacts to the Clerk of the Board for inclusion into the official File No. 231148.
