

1 [Accept and Expend Grant - Retroactive - San Francisco General Hospital Foundation -  
2 Behavioral Emergency Response Team (BERT), HIV (HIV Patients Experiencing  
3 Homelessness), and the Women’s Options Clinic - \$180,000]

4 **Resolution retroactively authorizing the Department of Public Health to accept and**  
5 **expend a grant in the amount of \$180,000 from the San Francisco General Hospital**  
6 **Foundation for participation in a program, entitled “Behavioral Emergency Response**  
7 **Team (BERT), Human Immunodeficiency Virus (HIV) (HIV patients experiencing**  
8 **homelessness), and the Women’s Options Clinic,” for the period of July 1, 2023,**  
9 **through June 30, 2024.**

11 WHEREAS, The San Francisco General Hospital Foundation (SFGHF) has agreed to  
12 fund the Department of Public Health (DPH) in the amount of \$180,000 for participation in a  
13 program, entitled “Behavioral Emergency Response Team (BERT), human immunodeficiency  
14 virus (HIV) (HIV patients experiencing homelessness), and the Women’s Options Clinic,” for  
15 the period of July 1, 2023, through June 30, 2024; and

16 WHEREAS, The Behavioral Emergency Response Team (BERT) plans to purchase  
17 patient care items for the BERT care kit for patients at discharge; and

18 WHEREAS, The human immunodeficiency virus (HIV) (HIV patients experiencing  
19 homelessness) program will use this funding to provide medication starter packs and food  
20 baskets for patients, along with supporting staff training and other program needs; and

21 WHEREAS, The Women’s Options Clinic will use the funds for medical supplies and  
22 food baskets for patients; and

23 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

24 WHEREAS, A request for retroactive approval is being sought because DPH received  
25 the memorandum on August 8, 2023, for a project start date of July 1, 2023; and

1           WHEREAS, The Department proposes to maximize use of available grant funds on  
2 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

3           RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
4 the grant budget; and, be it

5           FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
6 expend a grant in the amount of \$180,000 from the SFGHF; and, be it

7           FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
8 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

9           FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
10 Agreement on behalf of the City; and, be it

11           FURTHER RESOLVED, That within thirty (30) days of the Agreement being fully  
12 executed by all parties, DPH shall provide the final Agreement to the Clerk of the Board for  
13 inclusion into the official file.

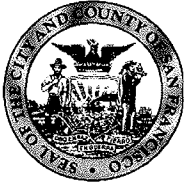




