The following information is provided by speaker(s), pursuant to Administrative Code, Section 67.16. The content is neither generated by, nor subject to approval or verification of accuracy by, the Clerk of the Board or the Board of Supervisors.

Anonymous submitted the following additional informatio during Public Committe on File No. 201342 as follows: "As a party before the SOTF, I will not speak in favor or against any specific person, but on the issues instead. I urge the Committee to appoint a full complement of SOTF members, and to immediately move forward on Seat 4, which has no competition, as with Member Hinze's departure the SOTF requires a 100% supermajority (6 of 6) vote for the public to enforce its rights of access, due to a lack of members. I also urge you to consider more journalists and more young people. Technology expertise has also proved critical, and the current members have that."
